4 FIRST AID MEASURES

General advice:	Move out of dangerous area. Consult a physician. Show this safety data sheet to the doctor in attendance.
lf inhaled:	If fumes or combustion products are inhaled remove from contaminated area. Lay patient down. Keep warm and rested.
