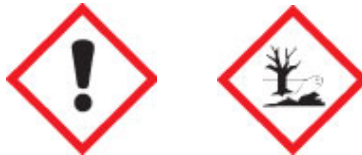

6 ACCIDENTAL RELEASE MEASURES
